2. Conduct detailed secondary research on the current landscape, growth drivers, challenges, regulatory environment, and investment trends.
3. Identify existing skill gaps, emerging job roles, occupational standards, and workforce requirements at various NSQF levels.
4. Map industry-academia-skilling ecosystem alignment and gaps.
5. Suggest policy recommendations and skill development strategies.
6. Submit a comprehensive final report (minimum 100 pages) along with infographics, data sets, interview transcripts, and executive summaries.

Financial Turnover	Minimum average annual turnover of INR 50 lakhs in the last 3 financial years
Technical Resources	At least 5 subject matter experts in electronics, policy research, or skilling
Compliance	Not blacklisted by any central/state agency or organization


